Dear Hon. John E. Mulhern, J.M.C. and Administrator Lorraine F. Lupo, Borough of Stanhope Court Administrator

1. As you may be aware, I am the author and publisher of The CAG Reports and also the internet published internet web site ThomasCaggiano.com that was filed by me in Federal District Court, E.D. PA. on Jan 5, 2009 with the Hon. Lawrence F. Stengel, J. and the U.S. Department of Justice with additional significant disclosure was on received by them on Apr 9, 2009 per the signed certified receipts. First page is at encl 1. These were then filed with the he Sussex County Prosecutor's David Weaver and the Sussex County Superior Court Criminal Part as continuing Defense Disclosure for the malicious criminal charges filed against me by Borough of Stanhope officials and employees and also one by Ms. Lupo which by its aftereffects as I was again arrested, fingerprinted again and again caused me to be taken by ambulance to the hospital as I have asthma and other breathing disorders that in reality drugs have NOT been able to address so I must use mentally controlled bio feedback but with my wife Kathryn who has a brain disorder and as we are both in therapy as were other Stanhope employees; such as, Ms. Robin Kline, RMC, MAS who suffered great mental and emotional injury in the criminal working environment of the Borough of Stanhope and at the verbal direction to me by the U.S. Department of Justice's Washington D.C. Office of Inspector General's Senior Special Agent Scott Meyers staff I placed her in the Federal Witness Blower Protection Program in the U.S. Attorney's Office in Chicago, Il as noted in the Jan 8, 2008 publication The CAG Report of Jan 8, 2009 which I certify all documents therein which are adopted by reference herein per N.J. Court Rules are true as they expose a massive federal and state criminal conspiracy which is documented in a DVD with 3.7 Gigs of evidence, which is the equivalent of 6 CDs of evidence which includes audio recordings, and digital images of letters, documents, plans, photographs and other evidence of the corruption of Borough of Stanhope Officials for over a decade.

2. There apparent crimes include those I noted in my letter to Judge Mulhern, Ms. Lupo, the Mayor of Stanhope Diana Kuncken and its Governing Body members on Apr 25, 2008 (first page, encl 2)

3. Ms. Lupo is aware I intend to file Affidavit of Probable Cause against her and dozens of officials and employees in the Borough of Stanhope for crimes that include pattern of official misconduct, fraud, bribery, crime against civil rights, and hundred of others as each payment to John Cilo Jr. Associates, Omland Engineering Associates, P. David Zimmerman who did NOT have validly awarded signed contracts per the Local Public Contracts Law with the required newspaper announcement is a criminal act of submitting the claim and a criminal act of disbursing the funds. These are particularly outrageous on those payments using money laundered through the Borough of Stanhope's Escrow Account to the Law firms of Laddey, Clark and Ryan, LLC, Dolan and Dolan PA the Land Use Board law firm which in fact received most of the funds as P. David Zimmerman for years by Borough of Stanhope officials in the Town Council and Land Use Board by fraud and trickery released false reports prepared by the professional planner P. David Zimmerman who was bribed at excessive fees to falsely state in Area in Need of Redevelopment Reports prepared by him criminally and with any signed written contract in reports given out free by the Borough of Stanhope by their conspirator to the public and have meetings in the American Legion Hall and High Point Condominium as the number of public persons interested were in the hundreds. At no time was P. David Zimmerman an Official of the Borough of Stanhope as stated in the reports as stated prepared for the Land Use Board and widely distributed causing U.S. Minerals, Peterson Tree Services and private home owners great emotional distress and great expense hiring lawyers as they believed at least that P. David Zimmerman was legally hired even though as noted on my web site the most the homeowners despised "was the lying by Borough of Stanhope officials".

4. While my wife and I left the United States of America for stress relief as ordered by many doctors we are both seeing as she is suffering greatly. Our voyage to the Bahamas was greatly uplifting of our spirits as can be seen in the attached photograph, encl 3 and we were given permission to leave the State of New Jersey for a month. We depart shortly so please review the many erroneous statements by Ms. Lupo in her repeated efforts which appear willful to prevent me from filing Affidavits of Probable Cause in the Borough of Stanhope as required by the Rules of the Court as I have done in the Township of Green, encl 4,5 and 6 which were completed per the rules of New Jersey courts in that the Affidavits MUST be signed by me under oath "Sworn to and subscribed before me this ____ day of ____ signed by the court person administering the oath. This is NOT the signature of a notary republic signing my name but confirming that an authorized State of New Jersey Judiciary court employee has administered the oath which Ms. Lupo herself previously told me when I appeared in the Borough of Stanhope municipal court to file Affidavits of Probable Cause for hundreds of separate criminal acts. The Borough of Stanhope with its accomplice the Morris/Sussex County Vicinage B. Theodore Bozonelis, Jr. conspired with the New Jersey Attorney General, the Department of Community Affairs, the Government Record Council, Laddey, Clark and Ryan LLC, Richard A. Stein, Esq. and Frankford Township officials as is proven beyond a reasonable doubt by the transcript of the temporary order issued by their accomplice as Richard Stein, Esq. committed false unsworn statements to the corrupt Judge and both violated the Rules of Ethics which do not appear to exist in Sussex County or Trenton Superior and municipal courts. Once the Affidavits are witnessed under oath, the New Jersey court rules have the court administrator issue Arrest Warrants or Subpeano forms in the computer to obtain a court docket number and against these are witnessed under oath after having been read by the Complainant filing the criminal charge per R: 7:2 PROCESS; specifically, R 7:2-1. by the complaining party and R 7:2-2(b) if CDR-1 is issued on a Complaint-Summons form or R 7:2-2(c) CDR-2 if an arrest warrant is to be done based upon the charge. Per court rules, this can be done by the judge, court administrator or even the deputy administrator. The statement made by Ms. Lupo "a private citizen can only file criminal charges if allowed to do so by a municipal judge" is clearly false and she is obstructing the administration of Justice, has a personal conflict of interest as I expect to file criminal charges against her and Richard A. Stein, Esq. as her accomplice in filing malicious fourth degree charges against me when she herself in my

presence telephoned the Township of Green's municipal court staff and confirmed I was directed by the corrupt Judge Dana, J.M.C. who is now exposed on two different municipal court transcripts costing me about \$4,000 that are now filed in Sussex County Superior Court of which he has refused to allow me to obtain under the Open Public Record Act or Municipal Court Record request a copy of these transcripts on a CD-ROM as required for various appeals per N.J. Court rules and has refused my written requests to even examine the more than 100 Defense Disclosure documents I submitted as part of Defendant's Disclosure which had motions which per court rules he must read prior to the trial beginning. These exculpatory evidence material was also per the rules of the court and Rules of Professional Conduct for lawyers and prosecutors such as the corrupt William Hinkes, Esq. who did Not even have a contract on Jan 7, 2009 when I was arrested without bail after conviction and immediately jailed not for 39 days but 85 days as the corrupt Judge Dana issued illegal and unconstitutional court orders violating all my civil rights and with the bodily harm as I required hospitalization as warned by my doctor many times is a series of first degree crimes which raises by the conspiracy all crimes to the highest crime so the second degree crimes of official misconduct,, false billings, illegal disbursement, perjury on Statement of Information requests signed by Richard A. Stein, Esq. in false responses to the original 18 Statement of Information forms submitted by the Borough of Stanhope to the corrupt Department of Community Affairs and its corrupt Government Record Council's executive director Catherine Starghill, Esq. is obviously beyond any reasonable doubt.

5. I request Judge Mulhern, J.M.C. to report under his duty of Code of Judicial Conduct both Richard A. Stein, Esq. his municipal prosecutor and his court administrator Lorraine F. Lupo to the appropriate authorities and at least hired some person that I do NOT have a conflict of interest to take the oath administered when I complete as required by court rules the Affidavits of Probable Cause.

6. Please provide me a written response by Jul 4, 2009 so that the Liberty of those signing our Declaration of Independence with our rights and duties to protect our community with our sacred honor and with our lives is Not further disgraced by the criminal conduct of Lorraine F. Lupo, Court Administrator. Encl 7 is a CD with a .mp3 file of my meeting with the First Assistant William Fitzgibbons, Sussex County Prosecutor's Office in his Grand Jury room with another detective years ago when I presented more evidence of the pandemic corruption in the Borough of Stanhope documented in the Voluntary Police reports in the Borough of Stanhope with a CD as my wife and I received four death threats after I testified under oath in the Land Use Board against State, Municipal officials, and others. Those audio recordings are available and will be posted on the internet during the fall with hours of audio recordings so the World can understand how corrupt the Borough of Stanhope despotic treasonous government is protected by corrupt judges and federal officials.

8. Please provide me a schedule when in mid Jul 2009 I can visit the court and signed under oath Affidavits of Probable Cause before the court administrator per her official duties. I certify the foregoing statements made by me are true. I am aware if any of the foregoing statements made by me are willfully false, I am subject to punishment.
