Dana, JMC and its prosecutor William Hinkes, Esq. who has confederated with the pathetic perjurer and deceitful Borough Attorney and Municipal Prosecutor of Stanhope Richard Stein, Esq., 150 Kennedy Road, Andover, NJ 07821

I am now a State of Nevada resident at the address listed above and conducted an initial review meeting the Federal IRS people therein to expose criminal conduct reported on my authored and published web site ThomasCaggiano.com/index.htm which was filed in the corrupt Sussex County Superior Court of Judge N. Peter Conforti, J.S.C. and its corrupt Sussex County Prosecutor David Weaver. The web site was also filed with the Federal District Court in E.D. PA and its U.S. Attorney's Officer located near the Independence Hall wherein the First Amendment to the U.S. Constitution is engraved in stone.

The New Jersey Constitution gives these rights affirmatively to the people of New Jersey.

Instead of a Code of Ethics under R 1:14 for Judges, Lawyers and Judicial Employees printed in New Jersey Court rules, a State Law called the Open Public Record Act giving any person the right to examine government records with few exceptions and the Open Public Meeting Act assuring its citizens to attend and observe public meetings at designated locations the court orders issued by Judge Bozonelis, Judge Manahan, Judge Dana, JMC, Judge Mulhern, JMC and Judge Browkley, JMC ALL violate these constitutional rights and or rights to due process and to file with probable cause hearings and under oath before an appropriate municipal court officer both affidavits of probable cause and the appropriate CDR-1 Summons or CDR-2. Instead in the State of New Jersey as noted on my updated Aug 1, 2009 web page with my new mailbox being FreedomNews@live.com and my new home as registered with the IRS, Social Security and U.S. Postmaster in Las Vegas, NV, we are citizens now of that State and of the pathetically corrupt State of New Jersey as shown in the over 100,000 pages of evidence distributed as authored publications and as required by direction to my by our corrupt Gov Jon Corzine in writing to report State crimes to New Jersey's series of corrupt Attorney Generals which do NOT enforce with its State's county prosecutors such as David Weaver violations of State criminal laws such as official misconduct, perjury, false imprisonment, assault, and the other 2C criminal codes listed in my Affidavits of Probable Cause filed in the Vicinage of Morris County and Sussex County with its un-

etical District X Ethics Committee and protection of corrupt Judges by the State's Supreme Court's Advisory Committee on Judicial Conduct which as volumes of evidence against many corrupt Judges since Jun 2008.

The latest criminal acts by Judge Dana even further limit my constitutional rights in the corrupt Township of Green in addition to the infested Borough of Stanhope which has dozens of voluntary police reports previously filed and the corrupt Judge Dana's order does NOT even allow Affidavits of Probable Cause to be filed per court procedures in Stanhope as I was recently fined again for sending a letter for an appointment to the tax assessor with a check for \$2,000 to pay county and local taxes so that I could complete as I did in Nevada an updated Estimated Tax Voucher for Federal Tax purposes as I am purchasing a new home at the above Aliante address, and had teams of contractors to fix garage doors, plumbing, and take measurements and paid for blinds. The plumbing design was changed and our new dishwasher was installed and door locks on our 3 bay garage, casita and main home.

Judge Dana's corruption is documented in now three transcripts costing me about \$5,000 in three municipal appeals. My defendant's disclosures on the malicious criminal charges for violation of the conspired Judge Bozonelis court order on a temporary revised docket now exceeds a year as NO examination of any Borough of Stanhope record is allowed under his corrupt order and he has wantonly ignored all motions presented to his corrupt court of confederated criminal agreement with the Borough of Stanhope and the corrupt Department of Community Affairs' and its corrupt Government Record Council with the support of New Jersey's corrupt Attorney General Anne Milgram, her corrupt Division of Law and other parties.

Fortunately, the latest corrupt Commissioner of Community Affairs Doria, Jr. has resigned in disgrace.

I hereby make an immediate motion to the Assignment Judge and Presiding Judge to suspend all decisions by Judge Dana who I and my wife Kathryn both filed criminal Affidavits of Probable Cause against for once again his official conduct was criminal and his court orders to jail me again, to deny me my U.S. Constitutional and N.J. Constitutional rights completely NOT only in Stanhope but his infested municipality are obvious. I even had my checks of \$250 I paid for OPRA and \$2000 for property taxes returned by the Corrupt Borough of Stanhope. The stench has now permeated to other states and countries by my postings on my public web site now published from NV.

I request the Superior Court to immediately suspend Judge Dana's illegal court order which even defines the court orders issued by Judge Bozonelis and Judge Manahan court orders. I desire a change of venue of my indictment before Judge N. Peter Conforti for as admitted on the court record by Judge Dana again he refused many witnesses in my defense, refused to allow entry of documentation sent to the State Department of Health that refuted Dr. Joseph's report and refused to allow my calling Dr. Paul who was the State's second person I met per the orders of Judge Conforti as my wife and I presented evidence beyond any reasonable doubt as the falseness of her reports and required the State of New Jersey to force into the admission of evidence exculpatory material the Probation Services corrupt officials therein were notified of their misconduct and their duty under the Ethics laws to be true to the Constitution of the United States of America and New Jersey and not to persons such as corrupt Judges as Judge Dana and Judge Conforti who like Judge Manahan without complying with N.J. Court rules and without any probable cause hearing despite having over 40 ft of adopted evidence in certified affidavits and volumes of evidence within the corrupt Office of N.J. Attorney General and the Sussex County Prosecutor's office illegally violating their Judicial Code of Ethics which apparently does NOT exist in New Jersey's courts to without an hearing drop dozens of sworn statements supported with requests for criminal investigation by State Senator Codey, our Federal Senator, Congressman, D-24 for-

mer State Senator, Assemblyman and Assemblywoman, twenty property owners have instead of complying with the Ethics codes used the court with out complying with laws or constitutions to wrongfully imprison me, tamper with witnesses and participate in a repeated pattern of official misconduct with breach of duty, outrageous conduct and causing emotional distress to many individuals.

I request the court order issued by Judge Dana be dismissed immediately as the trial was unconstitutional and the sentence, resentence and second resentence were all unconstitutional.

I request per the Rules of Conduct that Judge Dana be reported to the appropriate authorities as well as he conferates Richard Stein, Esq. and William Hinkes, Esq. and their law firms per NJ Ethics laws and NJ Court Rules and that the sham, the libel, slander, defamation of my character and terrorism and torture of my beloved wife who is requiring treatment be ended by the unending tyranny our community has faced for now seven years as documented in the DVD's hundreds of files provided in my defendant's exhibits to Judge Conforti and corrupt Sussex County Prosecutor's Office.

Please send me a copy of your response to my Nv home address and also the property we are attempting to sell and attempting to pay property taxes on to the corrupt, protected cease pool we have lived since we had our home constructed on 10 East Drive in 1972.

We desire to be free to leave this corrupt State to live in Nv as using FreedomNews with published news digest issued we will continue to expose per a duty imposed by the Declaration of Independence to support our Nation with our sacred lives to end the tyranny that engulfs New Jersey as exposed in the recent 44 arrests by FBI officials and resignations of State and Municipal officials that continue to disgrace the State of New Jersey as the corruption State.

The court administrator of Green is requested to provided me a date ASAP so that I may file dozens of Affidavits of Probable Cause therein against the Sussex County Probation officer, Judge Dana, Mayor, Joint Committee court members, Stanhope officials, State Police, etc based upon the \$5,000 in transcripts I have ordered in my many municipal appeals not only in the court Joint Court of Judge Dana but also the corrupt courts of Judge Bozonelis, Judge Conforti and Trenton Superior and Municipal court judges.
