I got a letter of notice of my municipal appeals for 13-04-09 and 19-05-09 as Oct 30, 2009 at 13:30.

Please tell me what cases these numbers are:

I filed several municipal appeals against the corrupt Joint Municipal Court Judge Craig U. Dana, JMC and his confederator municipal prosecutor and accomplice William Hinkes, Esq. Since the corrupt Sussex County Prosecutor David Weaver worked for William Hinkes law firm and his Asst Prosecutor Robin Lawrie is not only incompetent, violated the Rules of Ethics and Professional Conduct and Sussex County Superior Court Judge N. Peter Conforti, JSC participated with Robin Lawrie, AP in my prior appeal of a minor speeding ticket violation that was a fraud and transferred by the corrupt Judge Mulhern, JMC in Stanhope as he placed me into the SLAP program without allowing any witnesses in my defense such as Mary Pawar who complained in the court herself as she was intimidated, threatened by the corrupt District Attorney and lawyer Brian Smith who was the lawyer for the corrupt Department of Agriculture's State's Sussex County Soil Conservation District in Newton, NJ as the records of the corruption have been filed in dozens of agencies, and whereas the corrupt Judge Craig U. Dana won't even allow me to contact any current or for-

mer employee of the Borough of Stanhope in writing, telephone, or attend any OPEN PUBLIC meeting and the corrupt Richard Stein, Esq. of Laddey, Clark and Ryan LLC is such a liar, perjurer as can be read on the transcripts and even returned my check I paid for taxes as allowed by the corrupt Dana in his slander and won't even allow me to examine the records I gave him as defendant's disclose as admitted to on the court record, refused to allow me to have the audio recording of my kangaroo court so called trials, that I have filed Affidavits of Probable Cause against Weaver, Conforti, Bozonelis, Stein, Hinkes and dozens of others and in violation of court rules NO probable cause hearing is even allowed by any municipal judge in Morris County or Sussex County by order of the corrupt Vicinage presiding judge Thomas Manahan and I filed complaints to the corrupt New Jersey Superior court's Advisory Committee on Judicial Conduct exec dir Tonelli on the above Judges why should I come to this corrupt court?

The corrupt Judge Dana even refused to provide me the copy of the transcripts for which I paid \$5,000 on a CD ROM per NJ court rules so that I could even make an appeal to the NJ Appellate Court. The corrupt Morris and Sussex County Assignment Judge B. Theodore Bozonelis, AJSC issued his corrupt court order a temporary order which was issued years ago without any hearing and just lies by Richard Stein as noted on that court record as Richard Stein's nose must be over 100 ft long now as he is the string player with his corrupt Law firm of Laddey, Clark and Ryan LLC that is also complicit by NJ liability rules and rules of profession conduct.

These law firms in Sussex County and other corrupt law firms which seem pandemic in Sussex County as noted on my long published web site ThomasCaggiano.com and FreedomNewsDigest.com now, have DVDs with over 35 ft of evidence and cabinet draws full of evidence in the corrupt NJ Attorney General's offices of Div of Law, Department of Law and Public Safety, its corrupt Department of Consumer Affairs with its corrupt Board of Engineers and corrupt Board of Professional planners not to be outdone by the corrupt Trenton Superior Court Judges I had things with as I won't call them hearings as NO affiant was allowed to be cross examined, no witness were allowed and my check in Superior Court for cross complaints was even returned, the corrupt Trenton Municipal court's transcripts don't even have my trial wherein Stanhope's fellow conspirator the corrupt Department of Community Affairs' which has 12,000 pages of evidence in its corrupt Department of Codes and Standards which protects corrupt Construction Code officials such as Stanhope's Thomas Pershouse, its corrupt Government Record Council as shown on its own records thanks to the former chairman Vince Maltese, Esq who brought in a court reporter, recused himself, made suggestions via the Star ledger to change the Open Public Meeting Act to better protect and enforce the OPRA and then resigned.

The corrupt Robin Lawrie admitted in my prior appeal she didn't even read the evidence. Please give her a copy of this email and to Judge Conforti and the corrupt David Weaver and tell them to visit the Sussex County Board of Chosen Freeholders clerk across the street and

review the evidence I placed on the public record on Nov 5, 2008 at One Spring Street and go visit the corrupt Dolan and Dolan PA office around the corner and see the corrupt Borough of Stanhope's Land Use Board attorney's Roger Thomas, Esq. and John Leo, III or visit the corrupt Frankford Township and see all its records as its municipal prosecutor paid his associate prosecutor for years without any legal contract per the State's Public Contracts Law. In Stanhope the corrupt John Cilo Jr. Associates was paid for decades without any written contract as per NJ Case law since 1912 a contract MUST be written as a resolution is only allowing a contract and is NOT a contract. The loophole used by the corrupt municipalities filling Sussex County simply divide the fiefdoms among law firms and engineering firms that are puppets or worse, complicit in State crimes NOT prosecuted apparently by State county prosecutor's such as David Weaver who was previously employed by Hinkes' law firm which of course is also Newton's municipalities law firm.

The pandemic corruption is exposed in hundreds of court records already.

Please give a copy to those handling my indictment by the corrupt David Weaver and his other corrupt AP Corazza as the transcript of my so called hearing with no witnesses before the corrupt Judge Bozonelis wherein the corrupt Richard Stein's lies that I submitted eight hundred OPRA requests ALL on Zoning in Stanhope was just another lie as in fact a simple print-out provided from the GRC's on line data base shows you Richard Stein lies like a fish swimming in water as it must be natural for Sussex County lawyers to violate Ethics laws and be criminals with their sponsors in NO bid contracts for a generation while being bribed by money laundered through the town's own escrow account as false reports are made by the likes of professional planner P. David Zimmerman for years, distributed to Stanhope officials, have news bulletins written that are fraudulent, and stories in the so called Official Newspaper the N.J. Herald which continues these false stories.

I am now very glad to be a Nevada citizen with our new home in Aliante in beautiful North Las Vegas by the new route 215 with the 12,000 ft Mt Charleston where I'll be hiking to see waterfalls at 8,000 ft and the Las Vegas Mtn to the north.

I request a change in venue and a change in magistrate for the reasons noted above and in my many filings with the Superior court in Sussex County on these municipal appeals and my indictment.

I believe that is an obvious conflict of interest when I have filed criminal charges against Judge Conforti, David Weaver and dozens of others and NO probable cause hearing is allowed on any of these filed, signed affidavits of probable cause.

Since as stated on the record there can be NO due process when one is not allowed to even get a copy of the court documents I provided Judge Dana as Defendant's disclosure or examine any record in the Borough of Stanhope nor even make an appointment in its corrupt court

with its corrupt court

Administrator Lupo to file criminal charges against her, and dozens of officials in Stanhope for official misconduct, bribery, fraud, racketeering, trickery, et al for in New Jersey's Sussex County I have found out a citizen has NO civil rights, no voting rights, and is prosecuted, jailed, fined, libeled as twenty property owners as noted in letters in the corrupt Sussex County Superior Court by adoption by reference have simply requested since our initial petition regarding the illegally developed minor subdivision Comply with federal, state and municipal laws. In NJ, the victim is hit by State police, Jailed, handcuffed dozens of times for simply writing grievance as allowed by something called THE BILL OF RIGHTS which in the desoptic, terroristic State of NJ does NOT exist even as Mary Pawar screamed at the corrupt Judge Mulhern, JMC in Stillwater as she blocked his exit from that corrupt court: Why can't I testify?

I now longer have supervised probation by the corrupt Judge Dana as after filing criminal charges against the corrupt probation officer Jenn Jobbagy wherein she admitted she had NO authority to contact one doctor and did and did NOT contact the three doctors or theraphist are treating myself and wife for stress relief I had her enter into the court record her entire file.

Please give a copy to the corrupt AP Robn Lawrie, AP as she admitted she doesn't read evidence in my municipal appeal of my speeding ticket wherein the corrupt Judge conforti thru out as evidence the phoney calibration, unwitnessed calibration reports and then convicted me of something which he admitted he had NO evidence.

Such is life in the corrupt Sussex County Superior Courts and its municipal courts. Does a single honest lawyer or judge exist in New Jersey that complies with the Rules of Ethics for I have met none.
