Name one corrupt politician sent to federal prison that had a single State Criminal charge for conspiracy, official misconduct, complicity, crime of official depriaviotn of civil rights, falsifying records, criminal attempt, unlawful benefits for official conduct, bribery, false reports to law enforcement authorities, hindering apprehension or prosecution, disbursing moneys, incurring obligations in excess of appropriations, unlawful benefits acceptance, pnality for false contract payment claims, threats and improper influence in official and political matters, et. al. =====These State Criminal violations are condoned by the New Jersey Governor, the Judiciary which protect felons even when dozens and dozens of Affidavits of Probable Cause are filed in its municipal courts per rules governing its courts as the corrupt municipal judges in Newark, Newton, Green, Morristown do NOT even allow CDR-2 arrest warrants or CDR-1 summons to be entered by their corrupt municipal court administrators so dockets can be assigned, tracking of criminal complaints can be tracked by the public and dates governing filing and due process are afforded NOT only the criminal but the victim that is victimized by the FBI in NJ under the former corrupt Special Agent In Charge Weysan Dun who destroyed evidence, whose agents threatened me if I attempted to bring evidence to the Newark, NJ building they would have me arrested. Having been arrested, handcuffed dozens of times, hit by State Police in the Department of Community Affairs, banned from attending essentially ALL its Open Public Meetings in violation of the Constitution of the United States of America, N.J. A Superior Court finding tht I was illegally and wrongfully imprisoned NJSA 2C:13-3, with terroristic threats from Judge Dana against not only me but my wife Kathryn Caggiano was made Sep 9, 2010. The criminal indictment of me on 13 criminal charges under 08-09-316-I was dismissed by the corrupt team of Judge Conforti, JSC and the corrupt Sussex County Prosecutor's Office corrupt First Assistant Prosecutor Gregg Mueller. quest.==== 2. I have been an Office of the Attorney General's State Police Official Corruption Bureau witness with my wife Kathryn Caggiano for many years in the exposure of Government Corruption and to the U.S. Attorney General's Office in New Jersey, Chicago, IL and other locations. I have been contacted by the Washington D.C. Department of Justice's FBI's Public Corruption Bureau on numerous occasions and have been directed to provide evidence of federal crimes which include conspiracy, obstruction of justice, fraud, trickery, bribery and other laws such as 18 U.S.C., Title 18, Sections 241 and 242 as on Sep 9, 2010 in a Superior Court finding by N. Peter Conforti, JSC I was found to have been illegally imprisoned in Keogh Dwyer Correctional Facility for not 39 days but re-sentenced illegally to 85 days and then again illegally resented to 95 days by Judge Craig U. Dana, JMC and his confederate and corrupt person who posed as the Joint Municipal Court prosecutor. The OPRA custodians of each municipality have failed to respond my requests for a copy of a valid contract awarded to William Hinkes, Esq. law firm. This law firm previously had David Weaver, the current corrupt Sussex County Prosecutor as a law firm partner and did NOT recuse himself when I filed criminal indictable charges against both Craig U. Dana, JMC as did my wife under oath before the Township of Green's court administrator and signed a CDR under oath. NO probable cause hearing has ever been conducted on any of my more than 40 corrupt officials, and other persons bribed without contracts such as John Cilo Jr., Scarlett Doyle, P. David Zimmerman and Eric Keller, as each with the borough's accomplices defrauded the public for many years as known by many members of the Department of Community Affairs as thousands of records some signed by 14 citizens and other signed by 15 citizens were provided to the Department of Community Affairs and are filed in Federal District Court of E.D. PA, the Sussex County Superior Court wherein a DVD was provided as exculpatory disclosure containing audio recordings, photographs and images of letters and drawing and other documents in .doc format. This contained 6 CDs of relevant material and my criminal indictment on 13 malicious charges by Borough of Stanhope officials was dismissed on Sep 9, 2010. The fines on the forty four convictions of me by the corrupt Judge Dana were vacated by the Superior Court as well as all probation.==== 3. The Trenton Municipal Court refused to provide transcript records of my kangaroo court trial in Trenton's municipal court which would prove that Catherine Starghill, Esq. committed willful perjury and in fact many Judges were referred to the ACJC under Case File 2008-305 as criminal aide to other criminal to prevent the detection and apprehension of many dozens of crimes was obvious in the State's own Exhibit S-2 which the prosecutor did NOT provide me upon my many requests. Fortunately, Judge Ostrer felt the repeated delay impacting my municipal appeal was too great and his directed me to provide him a check for \$500 and that letter with my response was also provided the N.J. Attorney General Paula Dow, the U.S. Attorney Paul Fishman, the Department of Education which has undertaken an investigation, and the FBI and others.
