1. Based upon my personal knowledge, I filed criminal charges against the above State of New Jersey, Sussex County officials for numerous State indictable criminal charges in Newton Municipal Court inducing but not limited to criminal conspiracy which is a State criminal charges and Federal criminal charges, Obstruction of Justice and Government function and other crimes.

2. I at the direction of the Federal Government’s Department of Justice’s Washington D.C. Office of Inspector General am providing evidence against over a hundred persons and law

firms in New Jersey that have engaged in a wide spread cover-up of fraud, trickery, bribery, criminal coercion, abuse of court processes, witness tampering, false unsworn statements, false imprisonment, kidnapping, assault obtain benefits, and conspired with complicity of liability for another, have violated rules of ethics on a constant, planned, coordinated basis for years undermining the U.S. Constitution and N.J. Constitution, the Open Public Record Act, the Open Public Meetings Act, provided perjured Annual Financial Reports, used federal, state, county and municipal funds in a structure of Government functions to using overhead, escrow accounts and general vouchers moving grant funds and other funding sources to benefit themselves for power, ego and financial benefit illegally in an agreed upon, confederated repeated pattern of official misconduct as they were protected by its courts and the State of New Jersey's corrupt Supreme Court's Advisory Committee on Judicial Conduct and the Department of Community Affairs Government Record Council in issuing dozens of false "No Analysis" decisions based upon the corrupt Judge Craig U. Dana, J.M.C.'s dozens of convictions of Thomas Caggiano on petty disorder charges aided by over a dozen other corrupt Judges in the Judicial system and the executive branch's Department of Treasury's Office of Administrative Law offices in Newark, New Jersey. The corruption was spread from the State's capital in Mercer County by a corrupt Trenton Superior Court and corrupt Municipal Court, to Newark, Stanhope, Green, Fredon, Borough of Andover, Stillwater, Hopatcong, Frankford Township, Netcong and Newton as every municipal judge encountered was apparently corrupt. The saga of tyranny has continued through Oct 19, 2010 in Judge Conforti's corrupt criminal superior court by him and the Corrupt Sussex County Prosecutor's Office on my municipal appeals of the corrupt Judge Dana's convictions as all fines, all probation were vacated upon my prior Pro Se prepared motions under the municipal appeals and in "secret" the 13 malicious criminal charges filed against me by Stanhope Officials and Employees were dismissed with Prejudice against the State of New Jersey against my desires as by fraud Judge Conforti, JSC and the Sussex County Prosecutor's First Assistant Prosecutor dismissed the charges to prevent the exposure of massive corruption in Sussex County by engaging in a criminal public trial wherein over 100 persons would be called exposing the massive cover-up and planned efforts of the racketeering enterprise of Government itself.

3. The cases have currently been transferred to Morris County but I was NOT allowed to enter CDR-2 Arrest Warrant complaints into the Judicial record system therefore the public does NOT know such charges were placed by me and sent to Morris County Prosecutor's Office and the Vicinage Court Administrator. By this published record, as it is based upon my personal knowledge, court transcript records in various courts noted and published on <http://thomascaggiano.com> with great public interest as requests for investigations were requested by the former outstanding State of New Jersey Dept of Environmental Acting Commissioner Lisa Jackson now the Nation's EPA Administrator, Federal Senator Lautenberg, Congressman Frelinghausen, State Senators Codey and Littell, Assemblywoman Alison Mc Hose, Assemblyman Guy Gregg, more than fifteen property owners in the Borough of Stanhope, the Department of Education's auditor, the Office of New Jersey Attorney General's prior excellent Director of the Department of Consumer Affairs Kim Ricketts, the Office of Gov Ian Brennan who was removed from office after requesting an investigation that was blocked by the corrupt Department of Community Affairs string of corrupt Commissioners such as Susan Bass Levin and other Cabinet level officials including a string of corrupt State of New Jersey Attorney Generals from Peter Harvey, Farber, Stuart Rabner, Anne Milgram and the current Paula Dow, Esq as it appears pandemic in the State of New Jersey to pro-

protect Government and NOT defend as their oath's of office require WE THE PEOPLE's safety, health and tranquility which is the primary reason Government is formed and Judge Criag U. Dana's court order itself defines tyranny, and massive civil rights violations of our Nation's Bill of Rights for I have no rights as I was threatened with arrest on Oct 18, 2010 in the Borough of Stanhope if I attempted to examine my own court records or attempt to file complaints in its municipal court. The Oct 19, 2010 so called hearing in the corrupt Sussex County Superior Court was a sham and fraud as in the Oct 5, 2010 court order issued by the court no brief was even due for 21 days and on Oct 18, 2010 in Stanhope I was informed by the Town Administrator Richard Stewart who attempted to have me gain access to my court records he was falsely told by the corrupt Borough of Stanhope's municipal prosecutor/borough attorney and its primary tool of lies and deceit and perjury in courts and in Statement of Information and in filing Docket SSX-L-747-07 in Dec 2007 with the corrupt Assignment Judge B. Theodore Bozonelis, A.J.S.C. to prevent transfer from the Government Record Council denial of access in the complaint Borough of Stanhope v. Thomas Caggiano and the State of New Jersey's Department of Community Affairs' Government Record Council. By criminal confederation as noted in the transcript record itself of a preliminary hearing before the corrupt Judge Bozonelis, A.J.S.C. documented in the transcript record in Ind 08-09-316-I against me wherein the corrupt Judicial Judge admitted he had NO evidence presented by Richard Stein that as stated falsely by him to the corrupt Judge, I submitted eight hundred Open Public Record Act Requests ALL on Zoning. False news bulletins issued to thousands of Stanhope residents have been issued for years by the Borough of Stanhope to its citizens and property owners. Yet the corruption continues.

Below are Affidavits of Probable Cause signed by me under oath in Newton's Municipal Court in the corrupt Vicinage of Morris/Sussex County in Sussex County against Judge Conforti, J.S.C., Judge Mulhern, J.M.C. and First Assistant Prosecutor Gregg Mueller, Esq. Dozens of other Affidavits of Probable Cause were filed from Trenton's municipal court, Morristown's municipal court, Newark's municipal court to Newton's municipal court but the "system" of government tyranny without a single if needed Probable Cause hearing by any municipal judge being held.

I filed the Affidavits of Probable Cause against Judge Conforti, JSC and Judge Dana, JMC as shown by the stamps on copies I provided to the Sussex County Superior Court Criminal Part and the Sussex County Prosecutor's Office. I refer all investigators to the outstanding Criminal Court Deputy Vicinage Trial Court Administrator and also the excellent lead criminal part clerk Kay Mack for evidence as the former Alison Kuddar who handles municipal appeals does NOT handle my municipal appeal papers after she issued the Oct 5, 2010 court order for a hearing on Oct 19, 2010 with a court brief due on Oct 26, 2010. In my conversation with the former Judge Conforti, J.S.C. law clerk Stephanie Kul, Esq. she told me she did NOT prepare the court orders issued against me by Judge Conforti, JSC which in fact violated my civil rights and violated the Constitutions of New Jersey as have Judge Bozonelis, A.J.S.C., Shuster, J.S.C., Sypek, J.S.C., Mulhern, J.M.C., Browley Jr. J.M.C. and others in the Failed State of corruption and tyranny lead by its Governor's that do NOT perform their constitutional duty to assure the health and safety of its citizens are protected but instead protect Government and those that bribe them in the Pay-to-Play State of New Jersey.


