The former Town Administrator Teri Massood, was a criminal, conspirator, admitted she willfully destroyed evidence under oath before the corrupt Office of Administrative Law Judge J. Howard Solomon, ALJ in Newark's corrupt Office of Administrative Law when the corrupt Department of Community Affairs' (except the former GRC lawyer Vince Maltese, Esq., Sr. Case Manager Dara Lownie and now **CURRENT** Sr. Case Manager Frank Caruso who provided me five inches of evidence in response to my Open Public Record Act Request OPRA). Dana, JMC with William Hinkes, Esq in Green with the support of corrupt Borough of Stanhope Mayor Diana Kuncken and Laddey, Clark and Ryan's LLC Borough Attorney in Green as he committed willful perjury. Stein also committed perjury on Statements of INFORMATION sent to the GRC on 18 separate denial of access, lied to the felon and corrupt Judge Bozonelis, AJSC another corrupt accomplice with other judges in Newsrk, NJ Municipal court, Mercer County Superior Courts, Trenton municipal court and a corrupt NJ Supreme Court Advisory Committee on Judicial Conduct. The law must be changed that the Borough Attorney and Municipal prosecutor can NOT be the same law firm or lawyer. The State Soil Erosion and Sediment Control Act must be changed so that the public within 200 ft of any development is notified when a developer applies to the State's District for approval as without any notice there is no way for the public to appeal the approval as the State's corrupt Newton Sussex County Soil Conservation District shows how corrupt the process is by 2,700 pages of evidence in Project minor subdivision Block 10902 Lots 10 and 12 file box SH#44 and the Paramount Self Storage shows how corrupt the Notice of Violation process is as the State's inspectors write notes on reports and the corrupt Developer violated laws on a continuous basis for months pouring tons of sediment onto R 206 as State Police officers traveling the highway and the Stanhope Police protected the developer as dozens of complaints were provided and NOT one violation as the system is rigged for eventually a notice was sent but that too per the law disappears without any fine. Now that the Borough of Stanhope in violation of its own laws on Chap 2.2.d removal of town administrator has fired the witness to the FBI and the State Police's Official Corruption Bureau, threatened me with arrest when I attempted to see my own court records in Stanhope and the corrupt Superior Court's N.
