- (1) 11/03/08 The court was requested in a motion by the Sussex County Prosecutor's Office to recuse itself and Judge Conforti, J.S.C. from the Ind 08-09-316-I. and Judge Conforti, J.S.C. approved the motion removing himself and the Sussex County Prosecutor from the criminal indictment 08-09-316-I State of New Jersey vs. Thomas Caggiano on 13 separately filed complaints by the Borough of Stanhope officials and their employees. All charges were Dismissed with Prejudice against the State of New Jersey on May 11, 2010; however, this court order provided in violation of court rules NO explanation of the reason for dismissal and further more was based upon fraud and deceit by Judge N. Peter Conforti, J.S.C. and Sussex County's First Assistant Prosecutor Gregg Mueller for in violation of court rules there was NO motion in writing prepared by the Sussex County Prosecutor's Office.

- (2) The court order of Jul 19, 2010 denying a motions for sanctions by Judge Conforti, J.S.C. also was by fraud as the court order issued was NOT only unconstitutional violating the Constitution of the United States of America, the Constitution of New Jersey, but the Open Public Record Act, the Open Public Meetings Act and was self inconsistant as it included the corrupt Vicinage 10 Assignment Judge B. Theordore Bozonelis, A.J.S.C. under Docket SSX-L-847-07 filed by the corrupt Borough of Stanhope Borough Attorney Richard A. Stein, Esq. whose investigation by the District XA Ethics Committee and against William E. Hinkes, Esq. were begun by assigning an investigation against them both by the District XA Ethics Committee under Docket XA-10-018E which was elevated to the Supreme Court's Office of Attorney Ethics. William Hinkes, Esq. did NOT have any valid contract to be the Municipal Prosector in the Joint Municipal Court in Green, Fredon, Hampt on and Borough of Andover on Jan 7, 2009 per my Open Public Record Act request to the Township of Green's Open Public Record Act custodian as a fraudulant document was then provided which has an effective date AFTER the trial date for the services of William Hinkes, Esq as signed by the memorandum of agreement among the four municipalities. Judge Conforti, J.S.C. to confuse the public has cited that William Hinkes was not required to have a contract with the Borough of Stanhope where the malicious petty disorder charges were filed.
