Thomas Caggiano of the petty disorder charges filed by the corrupt GRC Catherine Starghill, the executive director under S2007-0754644. As noted in the transcript record obvious violations of Rules of Professional Conduct by the Trenton Municipal Prosecutor for the State of New Jersey was obvious by his statement: I object to his question (which was directed to Catherine Starghill who committed perjury under questioning by me as noted in the court transcript) BEFORE HE even asks it. And Judge Sancinio, JMC said: No, No. No, No Judge Sancinio violated the Code of Judicial Conduct by NOT issuing any Sancitions against witness I have issued valid subpeano as the Borough of Stanhope officials would have further shown that the statements by Catherine Starghill were also false and that in fact she and the Government Record Council conspired with the Office of Attorney General for New Jersey's Division of Law GRC Debra Allen, Esq. to obtain unconstitutional court or-

ders denying me the rights of Public Assembly at designated locations in the Department of Community Affairs in all other public meetings by any Department in the Department of Community Affairs in violation of the Bill of Rights and the ability to even contact the excellent Sr. Case Manager Frank Caruso who has provided additional NEW Evidence provided the Sussex County Superior Court of Judge Conforti, JSC and the State's Sussex County Prosecutor's Office that has hundreds of records proving my mind set was to provide a complaint to the Government Record Council that the procedure stated by the GRC's executive director that the GRC had NO authority by its own interim orders to even examine what the OPRA custodian was portraying as a valid response to an OPRA request. By their own GRC decisions, that statement was also false testimony by Catherine Starghill. Whereas Judge Sancinoto then AFTER being confronted with other false testimony by Catherine Starghill that the large exhibit S-2 contained vulgar and errors and could NOT name one page in the vast S-2 exhibit retracted the State's evidence submitted that proved the testimony by Catherine Starghill was not only deceptive, a violation of Rules of Professional Conduct by herself but in fact perjured testimony. Judge Sancinoto, had then only one page as evidence S-1 which was in fact only part of the totality of the documents sent NOT to Catherine Starghill but to her complicit superiors that HER actions were willfully designed to aide others in criminal conduct which directly impacted the safety, health and private property as shown beyond any doubt in my undisputed Voluntary Disclosure to the Municipal Prosecutor who was fully aware by those records and the State's own exhibit S-2 of my cooperation as a witness to the State Police Official Corruption Bureau for years. The other State's witness identified a diagram taken off the web site available to all persons which even removed diagrams of organs which are shown in millions of published documents. The Detective, a man, when asked what the diagram was illustrative of stated it was a woman. I noted as stated in reply and objected to by Judge Sancinoto: It was a diagram of a prostate gland, a man. The Judge stated I could only ask questions of State's witnesses but the municipal prosecutor even objected to questions before they were asked. There is NO evidence other than my doing a public duty to correct GRC procedures as my comments were in fact directed to the excellent GRC lawyer Vince Maltese, Esq. who in fact aided the public by bringing in a court reporter, leaving the room and allow the conduct of the GRC chairwoman and Catherine Starghill to be observed by State Police officials such as the excellent SGT Eric Fowlkes, Badge 4792 who personally prevented the Department of Community Affairs from forcing me from leaving the Department of Community Affairs' when I came to the State building to attend an Open Public Designated meeting of the GRC with my own complaints on the agenda and he personally protected me allowing me to stay and attend the Open Public Meeting as can be confirmed by both Vince Maltese, Esq as Sgt Fowlkes and I met the excellent Vince Maltese, Esq. in the GRC conference room after the GRC meeting was over as there was NO announcement to the public where I was sitting nor SGT Fowlkes that the GRC closed session was completed. Sgt Fowlkes was also in Dec 2009 in the Department of Consumer Affairs building in Newark, N.J. and I requested as a member of the State Police to escort me and observe the conduct of the Office of Attorney General's corrupt Department of Consumer Affairs staff inside the Department of Consumer Affairs, Board of Engineers and Board of Professional Planners with the Office of Attorney General's DAG Michelle Albertson, Esq. as she attended the investigative inquiry by the corrupt Board of Engineers for my complaint against professional engineer John Cilo Jr. who committed perjury for years in filing false perjured annual reports to the Department of Community Affairs known by the GRC as the former excellent municipal clerk Ms Robin Kline, RMC, MAS reported the criminal conduct to at least 10 agencies for 1.5 years including sending into the GRC itself during a three review delay with an 8 month interim order inquiry under GRC 2006-02 against the Borough of Stanhope that despite her diligent searches which including contacting the Mayor Diana Kuncken, the Governing Body, the firm John Cilo Jr., Associates and the prior Town administrator Teri Massood who ran away without any severance as falsely stated in news bulletins issued by fraudulent mailings to every property owner in the Borough of Stanhope that Teri Massood left because of a disagreement in management style which was false as she Teri Massood was a main implementor of the racketeering in the Borough of Stanhope with the corrupt Law firms Laddey, Clark and Ryan LLC, Dolan and Dolan PA as false reports were sent to the Office of Attorney General's Department of Consumer Affairs' Board of Engineers by them that falsely stated that John Cilo Jr. WAS the municipal engineer but in fact he, his employee Scarlett Doyle was bribed, incompetent pawns of the cesspool that GRC has protected with the exception of Vince Maltese, Esq. the mentally injured former Case Manager Dara Lownie and the excellent Sr. Case Manager Frank Caruso. I adopt all the reports available on <http://thomascaggiano.com/pdf> to support this motion for Dismissal with Prejudice, return of all fines, copy costs, travel costs, lodging costs, transcript fees to be determined upon verification of costs provided the Superior Court. I request the continued costs to me and my family and continued manifest injustice be stopped as my time is required as I am a witness to the U.S.P.S. Inspection Service for massive mail fraud, conspiracy and harassment as I spoke to their HQ in Az and the case has been reassigned within its HQ as the prior complaint number assigned by Peter Zegarac, Inspector in Charge is 16210546. I have visited the Mercer County Prosecutor's office three times providing the office and its Assistant Prosecutor's vast amounts of evidence of criminal corruption, criminal conspiracy, complicity and violations of the Open Public Meetings Act by the GRC itself and whereas I

have no standing to bring the civil complaint to a Superior Court as that action per the OPMA is the official duty of the Mercer County State Prosecutor who has refused to bring the violation of the OPMA to a Superior court as the GRC has refused for years to provide me copies of its agendas in advance as required by law and all such meetings thereby could have the actions by the GRC to deny all my Denial of Access complaints as stated in their own web site and decisions: NO analysis expunged. I request the court to direct the Mercer County Prosecutor's Office to respond to the court as to why the State prosecutor has NOT conducted or brought any action to the appropriate superior court as by his willful inaction to perform the Mercer's County Prosecutor's Office official duty to bring the civil suite before a Superior court, the GRC continues to violate OPMA which under false testimony on the court record in my municipal appeal Catherine Starghill committed additional perjured testimony. This motion will be provided hard copy PRO SE for filing and sent to the Mercer County Prosecutor's Office as I suggest his office or the court, stop this continuing fraud by Government officials in a large conspiracy that greatly injures my family's health, well being and stop the witness intimidation as the Borough of Stanhope fired its Town Administrator Richard Stewart from his \$109,000 municipal job as he had posted the required C.E.P.A. notice on the Borough of Stanhope's Bulletin Board and has been a cooperative witness performing his public duty as a witness to the FBI in Newark, NJ and the State Police Official Corruption Bureau. My POC in the West Trenton State Police Hq working directly for the Superintendent of State Police is SGT L. Littles-Flyd Bade 5375 telephone 609-882-2000 ext 6506. I object to have any hearing of a brief until court records from other courts are provided which have been denied as when I attempted to get court records that are relevant in the Borough of Stanhope, I was threatened with arrest and being jailed immediately as I am now a Nv state resident, and a Nv business owner of Inside on the Outside Reg Nv20011003435. I believe a decade of service providing evidence to the Government of massive corruption, being imprisoned falsely for 85 days, on SLAP for 15 days, being poisoned by the State with my red blood cells reduced by 50%, being defamed, slandered, libeled, being hit by State police, kidnapped from public meetings, paying thousands in lawyer fees, fines, being handcuffed over 20 times, having left the corrupt State of New Jersey and not being threatened by Judges, prosecutors, town municipal clerks, and can't even get to have my wife pay taxes, and herself being threatened by judges, and others for criminal conduct for requesting government records to sell my home and not allowing me access to court records or records needed to reduce my property taxes in Stanhope and more is enough as now having a Senior State Pass for Nv State Parks, being a senior citizen with a medicare card, after serving the defense of our nation for 30 years, after getting decades of education to support our nation, the time is better spent as I return to Long Island on Feb 1, 2011 to take care of my father who is in an assisted living home as he is 89 years old and to be with my brother, wife of 43 years and sister in law on our booked trip to Hawaii.
