1. Please find enclosed verified certified affidavits now filed in the corrupt Morris County Superior court, Morristown, NJ with its own corrupt Morristown municipal court that was provided dozens of Affidavits of probable Cause against dozens of corrupt Government officials and bribed laws firms representing the State of NJ and throughout Sussex County under Dockets SSX-C-043-13 and SSX-C-001-13. 
