TAKE FURTHER NOTICE: Having met teams of police officers in Las Vegas, North Las Vegas and Henderson numerous teams proving massive evidence, and directed by the Clark County District Attorney to provide a copy of my voluntary police report describing alleged criminal conduct as the Police and its Internal Affairs Bureau (IAB) both violated my civil rights to report crimes and obtain by Common Law rights of Access copies of records of my prior complaints to the Internal Affairs bureau under threat by 3 police offices in its Command Station, as numerous federal agencies violated my FOAI and U.S. Common Law rights of Access to obtain records by fraud, conspiracy - two or more people acting together - and threats are documents in complaints field with numerous enforcement agencies, federal senators and house members which directed e to file complaints to the Office of special Counsel (OSC) as President Trump fired the OSC as the US Appellate Division confirmed his authority as President , the Better Business Bureau upon receiving false information from Aliante Master's Association Community Management firm Firstservice Residential which has engage in massive continuous violations of federal ,state, county and municipal laws for over a decade including NRS code violations has also been protected by the NV Business and Industry Division, the NV Real Estate Division, its CIC Ombudsman as the Consumer Financial Protection Board as also done by Thomas Caggiano have entered massive evidence of criminal conduct by the HOAs AMA and its subassociation Autumn Ridge at Aliante Community Association with over 10,000 unit holders as the Federal Trade Commission has filled upon its allocation space in the Consumer Sentinel Network with evidence from Thomas Caggiano as police officers did file CDs of evidence agaisnt officials, enforcement agencies in Las Vegas, Clark County and the State of Nevada including the FBI in Nevada and Washington DC which as protected Clark County, municipalizes and other accomplices 18 USC Section 3 which requires no overt act to be a criminal violation, 18 USC Section 4 Misprision of felony in a continuing conspiracy

Senator Cortez-Masto, Esq. as NV G referred me to the FBI regarding violations of 18 USC Sections 241 and 242 and also violation of Police Manual, Procedures et. al noted in the Police manuals as the DOJ and FBI have been constantly violating the Justice manual including Judges in Las Vegas, and NV Court Appellate Division staff in Carson City known the Carson City District Attorney, Carson City's Board of Supervisors and District Attorney and other Mayors in Nevada, news media, et. al.

6. In my opinion, the State of Nevada is the most corrupt State in USA lead by Clark county as Gov Sisolak, the former Clark County Commsioner (D) was followed by Gov Joseph Lombardo (R) the former Clark County Sheriff (R) and also chief of Las Vegas Police (R) protected by Las Vegas members on the Las Vegas Fiscal Affairs Committee and Las Vegas Civilian Review board for years as Lombardo and Ford of different parties protect one another protected by CIGIE, GAO Fraudnet, OSC, FBI and other accomplices all whom violate their oaths of office defined as perjury to self benefit themselves , Clark County and the State of Nevada

7. In HOA meetings the President of both HOAs, Michael Breault stated: "I am honored to be protected by the FBI" for as shown now by US AG Bondi, Esq in massive removal of federal attorneys, and security clearances and staff has already taken place as well as firing of the OSC and OGE director by President Trump after he had to file an appeal to the US District Court which unanimously agreed the President had the authority to remove the director of the OSC, to which I was directed by oversight committees in the Senate and filed complaints to the OSC, Office of Professional Responsibility for DOJ and separately FBI, and US District Court District of Colombia's Appellate Division Board of Professional Responsibility against FBI director Chris Way, Esq. and his FOIA office which lost many cases violating willfully FOIA requesters access for FBI records such as Judicial watch and others.. which would expose he Deep State now being investigated by US AG Pam Bondi and FBI director Kash Patel as the FBI director Wray resigned before Trump could as he stated fire Chris Wray.

8. NRS 173.049 Court clerk may accept information filed electronically; procedure; service.

1. A court clerk may accept an information filed pursuant to this chapter that is filed electronically. An information that is filed electronically must contain an image of the signature of the prosecuting attorney.

2. If a court clerk accepts an information that is filed electronically pursuant to subsection 1, the court clerk shall acknowledge receipt of the information by an electronic time stamp and shall electronically return the information with the electronic time stamp to the prosecuting attorney. An information that is filed and time-stamped electronically pursuant to this Section may be converted into a printed document and served upon a defendant in the same manner

as an information that is not filed electronically.


NRS 173.055 Duties of district attorney or Attorney General; written statement containing reasons why information not filed.

1. The Attorney General when acting pursuant to a specific statute or the district attorney of the proper county shall inquire into all cases of preliminary examinations as provided by law, concerning the commission of any offense, whether the offenders are committed to jail, recognized or held to bail.


2. If the district attorney or the Attorney General determines in any such case that an information ought not to be filed, the district attorney or Attorney General shall file with the clerk of the court having jurisdiction of the supposed offense a written statement containing the reasons, in fact and in law, for not filing any information in the case. The statement must be filed within 15 days after the holding of the preliminary examination.

NRS 173.065 Judge may require Attorney General to prosecute if district attorney refuses. The judge of the court having jurisdiction may in extreme cases, upon affidavit filed with the judge of the commission of a crime, require all available evidence to be delivered to the Attorney General for prosecution, if the district attorney refuses to prosecute any person for such crime.
