This is in response to your facsimile dated February 2, 2011, forwarding a letter of concern from your constituent Thomas Caggiano. In his correspondence, Mr. Caggiano alleged widespread corruption in the state of New Jersey (NJ), and that he has received threats from various NJ officials. Mr. Caggiano also alleged corruption within the Department of Justice, to include the Federal Bureau of Investigation (FBI).

Beginning in December 20, 2006, this office has received numerous complaints from Mr. Caggiano reporting the above referenced allegations. On January 22, 2007, Mr. Caggiano's allegations were referred to the FBI, Inspection Division, and the Executive Office for U.S. Attorneys, and he was advised of those referrals in a letter dated January 22, 2007. On September 6, 2010, additional allegations received from Mr. Caggiano were referred to the FBI, Inspection Division, for appropriate handling. On that same date, Mr. Caggiano was sent a letter advising him of the referral and that the Office of the Inspector General considered this matter closed.


Dear Mr. Caggiano:



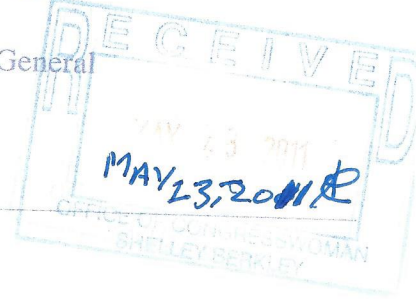

On that same date, Mr. Caggiano was sent a letter advising him of the referral and that the Office of the Inspector General considered this matter closed.

Ms. Egea, whom Mr. Christie has named to be his next chief of staff, said she would text the governor infrequently, and he would respond "at times." Sometimes, she deleted messages in her phone, Ms. Egea testified, adding she thought she deleted the messages before the bridge issue became a national scandal—but couldn't be sure.

It is unclear exactly what the messages said. When asked if she would try to find and produce such messages, an attorney for Ms. Egea wouldn't comment.

Now, after the bridge scandal, Ms. Egea said she would keep such messages. "We've all been refreshed on the requirement to retain documents," she said. The Christie official faced sharp questions and deep skepticism from legislators who are investigating why two lanes of traffic were closed for more than four days in September. The lane closures created a scandal that has challenged Mr. Christie's administration, now under the cloud of several investigations.

Over and over, lawmakers pressed Ms. Egea on why she didn't do more after learning of the lane closures within hours of their reversal on Sept. 13. Bill Baroni, then the Port Authority's deputy executive director, forwarded her an email from Patrick Foye, the agency's executive director, that said the lane closures were a life-threatening situation.

Mr. Baroni disputed Mr. Foye's account to Ms. Egea, who said she thought the email seemed "overzealous" because officials from both states often fought. She didn't notify Mr. Christie's office of the note, she said.

"The longer there was no evidence produced after such an elaborate email," she said, her belief grew that "there was nothing there."

Title 18, U.S.C., Section 241
Conspiracy Against Rights

This statute makes it a crime for any person acting under color of law, statute, ordinance, regulation, or custom to willfully deprive or cause to be deprived from any person those rights, privileges, or immunities secured or protected by the Constitution and laws of the U.S.

This law further prohibits a person acting under color of law, statute, ordinance, regulation or custom to willfully subject or cause to be subjected any person to different punishments, pains, or penalties, than those prescribed for punishment of citizens on account of such person being an alien or by reason of his/her color or race.

Acts under "color of any law" include acts not only done by federal, state, or local officials within the bounds or limits of their lawful authority, but also acts done without and beyond the bounds of their lawful authority; provided that, in order for unlawful acts of any official to be done under "color of any law," the unlawful acts must be done while such official is purporting or pretending to act in the performance of his/her official duties. This definition includes, in addition to law enforcement officials, individuals such as Mayors, Council persons, Judges, Nursing Home Proprietors, Security Guards, etc., persons who are bound by laws, statutes ordinances, or customs.

Punishment varies from a fine or imprisonment of up to one year, or both, and if bodily injury results or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire shall be fined or imprisoned up to ten years or both, and if death results, or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, shall be fined under this title, or imprisoned for any term of years or for life, or both, or may be sentenced to death.

Title 42, U.S.C., Section 14141

Makes it unlawful for state or local law enforcement agencies to allow officers to engage in a pattern or practice of conduct that deprives persons of rights protected by the Constitution or U.S. laws. This law, commonly referred to as the Police Misconduct Statute, gives the Department of Justice authority to seek civil remedies in cases where law enforcement agencies

have policies or practices that foster a pattern of misconduct by employees. This action is directed against an agency, not against individual officers. The types of issues which may initiate a pattern and practice investigation include:

- Lack of supervision/monitoring of officers' actions;
- Lack of justification or reporting by officers on incidents involving the use of force;
- Lack of, or improper training of, officers; and
- Citizen complaint processes that treat complainants as adversaries.

Under Title 42, U.S.C., Section 1997, the Department of Justice has the ability to initiate civil actions against mental hospitals, retardation facilities, jails, prisons, nursing homes, and juvenile detention facilities when there are allegations of systemic derivations of the constitutional rights of institutionalized persons.



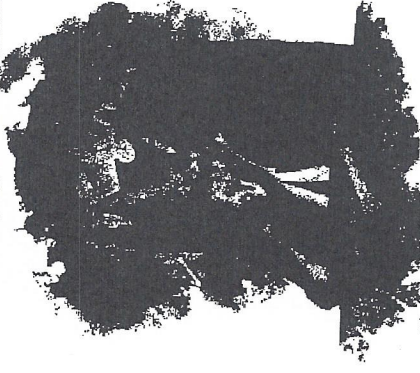

"OPRA is designed to advance this policy by broadly defining government records," N.J.S.A. 47:1A-1.1, and by publicly declaring that they shall be accessible, N.J.S.A. 47:1A-1."

"The common law right [of access] can reach a wider array of documents than its statutory counterpart [OPRA]." *Educ. Law Ctr., supra*, 198 N.J. at 302 (citing *Higg-A-Rella, Inc. v. Cnty. of Essex*, 141 N.J. 35, 46 (1995)); see also *Home News v. State, Dep't of Health*, 144 N.J. 446, 453 (1996). "However, the common-law right of access is not absolute." *S. N.J. Newspapers, Inc. v. Twp. of Mt. Laurel*, 141 N.J. 56, 72 (1995); see also *Home News, supra*, 144 N.J. at 453."

The common-law right to access public records depends on three requirements: (1) the records must be common-law public documents; (2) the person seeking access must establish an interest in the subject matter of the material; and (3) the citizen's right to access must be balanced against the State's interest in preventing disclosure.
