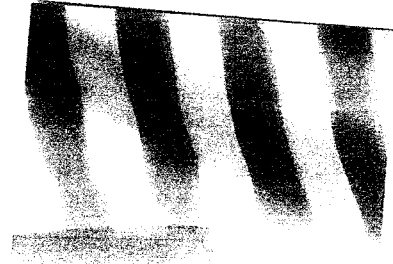

Thank you for your recent correspondence dated September 19, 2016, which was recently referred to the Municipal Court Services Division of the Administrative Office of the Courts, Judicial Services Unit for a response.

In your letter you expressed concern regarding the conduct of the Municipal Courts in the City of Trenton, Wantage Township and Hopatcong/Stanhope. You explained that you have been seeking, but have been unable to obtain, records relating to your cases with these courts. 

The ACJC is the arm of the Judiciary created to investigate allegations of unethical judicial conduct. 


Dear Congresswoman Berkley:

This is in response to your facsimile dated February 2, 2011, forwarding a letter of concern from your constituent Thomas Caggiano. In his correspondence, Mr. Caggiano alleged widespread corruption in the state of New Jersey (NJ), and that he has received threats from various NJ officials. Mr. Caggiano also alleged corruption within the Department of Justice, to include the Federal Bureau of Investigation (FBI).

Beginning in December 20, 2006, this office has received numerous complaints from Mr. Caggiano reporting the above referenced allegations. On January 22, 2007, Mr. Caggiano's allegations were referred to the FBI, Inspection Division, and the Executive Office for U.S. Attorneys, and he was advised of those referrals in a letter dated January 22, 2007. On September 6, 2010, additional allegations received from Mr. Caggiano were referred to the FBI, Inspection Division, for appropriate handling. On that same date, Mr. Caggiano was sent a letter advising him of the referral [REDACTED]

Dear Mr. Caggiano:

This is in response to your April 18, 2014, letter, in which you sought to appeal the Treasury Inspector General for Tax Administration's (TIGTA) March 18, 2014, response to your Freedom of Information Act (FOIA) request dated January 29, 2014 and your perfected FOIA request dated February 7, 2014. In your January 29, 2014 request, you sought copies of TIGTA complaints you filed with TIGTA, all emails you sent the Internal Revenue Service (IRS) and TIGTA from the email address thomascaggiano@gmail.com, and copies of all evidence you provided to the IRS Special Agents in Las Vegas, Nevada. You stated that the relevant complaint numbers were 54-1206-0001-C and 54-1104-0005-C. In your February 7, 2014 perfected request, you corrected the complaint number 54-1104-0005-C to 54-1103-0005-C. You also modified your request to include complaint number 54-1401-0072-C with the records you are seeking, and you specifically stated that you wanted the records you provided to John Kirk, who is a TIGTA employee, and to Joel Ernst and Jarrett Wade, who are IRS employees. Finally, you modified your request to add Department of Justice (DOJ) Case File DA30037340 to the records you are seeking.

TIGTA's Disclosure Officer determined that TIGTA Complaint Numbers 54-1206-0001-C, 54-1103-0005-C, 55-1401-0072-C and 63-1306-0034-C, consisting of a total of 111 pages were responsive to your request. By letter dated March 18, 2014, the Disclosure Officer responded to your FOIA request. The Disclosure Officer released a total of 49 pages of responsive documents in full and 55 pages in part. The Disclosure Officer advised you that a total of seven pages of responsive documents were being withheld in their entirety. You were also advised that FOIA subsections (b)(6) and (b)(7)(C) were being asserted as legal justification for withholding the information not released to you.

In addition, in the March 18, 2014 letter, the Disclosure Officer informed you that to the extent you are requesting documents pertaining to third parties, TIGTA can neither admit nor deny the existence of responsive records. The Disclosure Officer further informed you that since Mr. Ernst and Mr. Wade are IRS employees, you may wish to contact the IRS Disclosure Office if you are seeking specific records regarding your contact with them as IRS records fall under the jurisdiction of the IRS. Finally, the Disclosure Officer advised you that with respect to your request for DOJ records, TIGTA

does not have jurisdiction over such records and that your request for these records should be directed to DOJ's FOIA Officer.

After a careful review of the information at issue, we have determined to uphold in part the Disclosure Officer's determination. At this time, we have concluded that 3 pages of documents previously withheld in part may be released to you in their entirety. Copies of these 3 pages are enclosed with this letter. Accordingly, a total of 52 pages of documents responsive to your request have now been released to you in their entirety. We continue to withhold a total of seven pages in full and 52 pages in part. We assert FOIA subsections (b)(6) and (b)(7)(C) as the legal justification for withholding the information not released to you.

FOIA subsection (b)(6) protects information about individuals in personnel and medical and similar files when the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy. The United States Supreme Court has made clear that the term "similar files" is to be interpreted broadly to include all information that applies to a particular individual. Some of the information responsive to your request includes information pertaining to individual(s) other than you, such as name(s), address(es), taxpayer identification number(s), and other information related to your complaints about third parties. All of this information could directly or indirectly identify the third party or parties involved. We have determined that release of the withheld information would not shed any light on TIGTA's performance of its official functions, and therefore, there is no public interest in this information as that term is defined for purposes of the FOIA. A requester's private need for information plays no part whatsoever in determining whether disclosure is warranted. Accordingly, we assert FOIA subsection (b)(6) as legal justification for withholding all information pertaining to any third party or parties.

FOIA subsection (b)(7)(C) protects from disclosure "information compiled for law enforcement purposes" the release of which "could reasonably be expected to constitute an unwarranted invasion of personal privacy." 5 U.S.C. § 552(b)(7)(C). The information responsive to your FOIA request was compiled in connection with your complaints about possible violations of the law, and therefore, was compiled for law enforcement purposes. The information being withheld in response to your FOIA request would reveal personal information about individual(s) other than you such as name(s), address(es), taxpayer identification number(s), and other information related to your complaints about third parties. All of this information could directly or indirectly identify the third party or parties involved. We have determined that release of the withheld information would not shed any light on TIGTA's performance of its official functions, and therefore, there is no public interest in this information as that term is defined for purposes of the FOIA. A requester's private need for information plays no part whatsoever in determining whether disclosure is warranted. We conclude that the privacy interest of the individual(s) to whom the documents pertain outweighs the public's interest in having the information released. Therefore, we assert FOIA

subsection(b)(7)(C) as additional legal justification for withholding information pertaining to any third party or parties.

This letter constitutes TIGTA's final decision with respect to your FOIA appeal. The FOIA requires us to advise you of the judicial remedies granted in the Act. You may file a complaint in the United States District Court for the district in which you reside, or have your principal place of business, or in which the agency records are located, or in the District of Columbia.

In addition, as part of the 2007 FOIA amendments, the Office of Government Information Services (OGIS) was created to offer mediation services to resolve disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. Using OGIS services does not affect your right to pursue litigation. You may contact OGIS in any of the following ways:

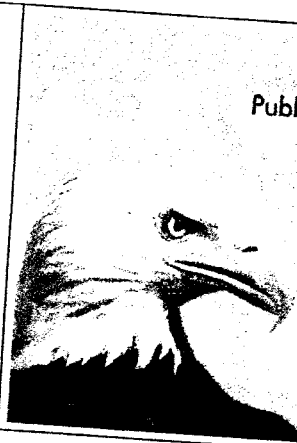

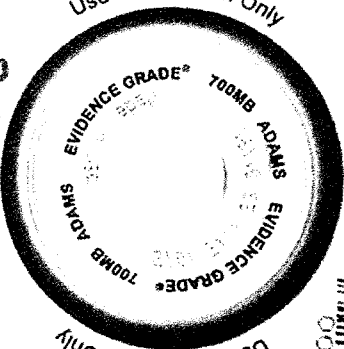
