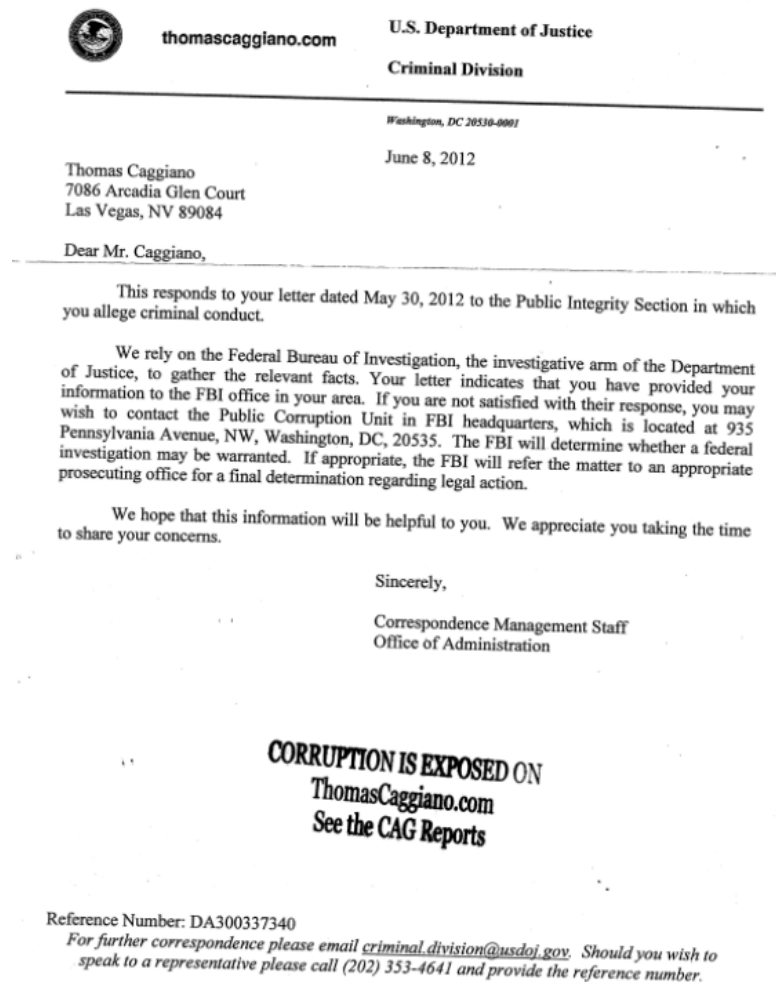

This letter is a complaint of vast public corruption on a sustained, repeated pattern of agreed alleged criminal conduct to obstruct the administration of law, violations of the constitution of the United States of America, its Bill of Rights, rights of due process wherein bribery, trickery with informant retaliation, assault against me by State of New Jersey police as I attempted to make an appointment to provide evidence of mail fraud, tax fraud, complicity, criminal coercion, destruction of government records, denial of court records and government records, money laundering, criminal disbursement of federal, state of New Jersey funds, violations of public safety and health laws, HIPPA rights, perjury by government officials, threats made against me of tax audits and criminal charges against me by IRS Special Agents in Las Vegas, Nv, false imprisonment, violation of my religious, voting and civil rights in an ever growing massive criminal conspiracy with vast criminal complicity in a pattern of agreed upon criminal conduct in structured enterprises defined as racketeering in the federal government as well as the State of New Jersey's more than dozen corrupt cabinet level Officials including the State of New Jersey Attorney Generals under the protected Gov Jon Corzine (D) and Gov Chris Christie administrations continuous with manifest injustice to dozens of convicted persons in multiple municipalities and were in Affidavits of Probable cause are NOT given due process or even filed with the Essex County, Mercer County, Morris County nor Sussex County prosecutors and by fraud the Office of Administrative Law and the department of Community Affairs' Commissioners from Susan Bass Levin. Esq. Gov Corzine's campaign manager through the current Commissioner of the Department of Community Affairs, Secretary of Agriculture, Commissioner of Mental Health Services, Director of the NJ Criminal's Department of Law and Public Safety, Director of Division of Law, Director of Consumer Affairs with the exception of Director Kimberly Ricketts who notified the U.S. Attorney (N.J.), the Director of Agriculture as the Secretary of Agriculture engaged in fraud and cover-up and filing false malicious quasi-criminal charges by the corrupt Sussex County Soil Conservation District's Clifford Lundin, its Board of Superiors and its manager and filed inspectors in planned coordinated filing with its corrupt executive secretary for the State Soil Conservation District's Office of Attorney General Division of Law's Deputy Attorney General and protected by the corrupt Judge Dana, J.M.C. and its municipal prosecutors as the Supreme Court of New Jersey's Advisory Committee on Judicial Conduct (ACJC), its Office of Attorney Ethics (OAE) and its Supreme Court investigator Harry Norton Jr. Woodland Park, N.J., for the allegedly corrupt Passaic County District Ethics Committee, its Supreme Court's Office of Administrator of Courts (OAC), and Disciplinary Review Board (DRB), the Mercer County District Ethics Committee and Morris County/Sussex County District Ethics Committee and Vicinage Assignment Judges and other Superior Court Judges and more than a dozen municipal judges from the City of Trenton, City of Newark, Morristown, Netcong, and through out municipal judges in Sussex County including many U.S. Attorney offices, FBI organizations in many states, Office of Governor of New Jersey, the Chief of NJ's Supreme Court Stuart Rabner, the former corrupt State of New Jersey Attorney General and former counselors to the corrupt ex-Governor Jon Corzine and ex-U.S. Attorney Chris Christie now Gov of N.J., and over 200 persons mostly federal, State of New Jersey officials in the executive, legislative and judicial branches at all levels protect them and violate Title 18 Section 4 in a broad ranging conspiracy for over 10 years as noted on the publicly available web site <http://freedomnewsdigest.com> or directly via <http://thomascaggiano.com> filed in Federal District Court of Eastern District PA against numerous federal Departments of Justice officials noted below:

Whereas investigations have been requested by NJ federal Senator, NJ Congressman in NJ and Congresswoman in Las Vegas, Nv, State of NJ Senators Codey and Littell, representatives of NJ's General Assembly Alison Mc Hose and Guy Gregg, NJ's Department of Environmental Protection's Deputy Commissioner for Compliance Enforcement Lisa Jackson who was aware of the conspiracy (now EPA Administrator as she requested two reviews and was provided false and deceptive responses by the HQ, Department of Agriculture's executive secretary of the State Soil Conservation Committee James Sadley and his assistant

Frank Minch in her Trenton HQ DEP office and by the corrupt State of NJ's Sussex County Soil Conservation District, investigations were also requested by the Sussex County Administrator, Newton, NJ and more than a dozen citizens as they have also been retaliated against, threatened, et. al. such as my wife Kathryn Caggiano, Mary Pawar and Iqbal Pawar f 12 East Drive, Stanhope, N.J., the former municipal clerk Ms. Robin Kline who was threatened and terrorized and suffered great psychological harm as she even hired her own attorney Mr. King. Esq. and reported the corruption to the State of NJ's FBI and nine other organizations, Ann Sheridan, RMC the court administrator who could no longer handle the massive judicial corruption in Vicinage 10 Sussex County/Morris County who suffered mentally, cried and eventually left on disability, Richard Stewart who was defamed by mayors and officials and was fired from the \$106,000 job as the Borough of Stanhope's Town Administrator after he reported the massive public corruption that continues to engulf the federal, state, municipal officials in many states as the cover-up of federal crimes that have as penalties life sentences or death sentences with tyranny continue unabated and State of NJ criminal acts not only in the second degree but rise to the first degree as I was kidnapped, assaulted, had HIPPA data obtained which itself was false, have false judicial records entered into Superior court records and corrupt quasi-criminal convictions for reporting the violation f health and safety laws, construction codes as required by State law NJSA 2C:2-1 Crime of Omission as Mary Pawar, Kathryn Caggiano and I wrote the corrupt Office of N.J. Attorney General (and infested enterprise under a series of corrupt NJ Attorney Generals protected by NJ's representatives other then a handful which themselves requested criminal investigations) as I was threatened by the FBI in NJ for reporting federal crimes, threatened by IRS Special Agent John Kirk as know in my complaints to his superiors as reported to TIGTA again to Special Agent Bruce Mason (Az) complaint 54-1206-0001-C as other witness who have reported the corruption to the FBI and N.J. State Police Official Corruption Bureau include the outstanding Tana Ell, the current court administrator 888 State Route 23. Wantage, NJ 07461. Phone: (973) 875-7310 in the Joint Municipal court of Wantage, Stillwater and Borough of Sussex in Green Township and former excellent deputy court clerk in the invested County Seat in Newton, N.J., the criminal court staff member in the infested Sussex County criminal division Kay Mack (973-579-0633) and as noted on the audio recording among the former State of NJ Sussex County First Assistant Prosecutor William Fitzgibbons, Sussex County, 19-21 High Street, Newton, N.J. 07860 he and another Sussex County detective working for he corrupt Sussex County Prosecutor David Weaver, Esq. recused himself then because of the great stress suffered a stroke and then retired as I myself had drugs forced into my body by corrupt organizations reducing my red blood cells by 50%, was hospitalized more then three times as the stress aggravated my asthma, was jailed multiple times by corrupt judges, could not even contact or write the corrupt municipal government. obtain court records in my own defense as due process, the constitutions of U.S.A. and NJ mean nothing, as 100 judges and prosecutors and government attorneys have themselves conspired together for over a decade of public corruption, threats, assault causes great harm to those that reported federal and state criminal conduct that continues unabated for even fleeing our NJ home for safety we were attacked by mail with threats and could NOT even met with any special agent for the FBI in Las Vegas when I went to its HQ there as the public corruption and cover-up is pervasive and continued apparently NOT for only 12 years but 30 years as the corrupt Borough of Stanhope's Laddey, Clark and Ryan LLC's Borough Attorney Richard A. Stein, Esq., 80 other attorneys and 20 judges and judicial court staff, probation office and the corrupt Department of Mental Heath Service's and her An Klein's CEO Mr. Main and mental evaluators who use conflicting mental filed evaluation reports use HIPPA data as tools of revenge, denial of all rights by defamation and used as tools by the corrupt Judge N. Peter Conforti, J.S.C. in the corrupt Sussex County Superior Court to deny all rights in a criminal conspiracy with many corrupt Sussex County Assistant Prosecutors as known to the FBI and Gov Christie (NJ) to use its court orders to deny civil rights as both I and Robert Mattia, Esq the court order attorney who was NOT paid by me or the State demanded by motion NOT to represent me as I entered motions also ignored and false entries were made into the Superior Court records, and based upon fraud itself also the 13 criminal charges filed by corrupt Borough of Stanhope Officials were all DISMISSED WITH PREJUDICE AGAINST the STATE OF NEW JERSEY in IND 08-09-316-I State of N.J. vs. Thomas Caggiano as municipal prosecutors destroy their records in violation of law, as the Department of Consumer Affairs, Office of the Attorney General's Department of Community Affairs' Board of Engi-

neers is a hive of official corruption wherein the bribed John Cilo Jr. had his attorney threatened Mary Pawar as did the corrupt State's District Attorney Brian Smith, Esq as she was even subpoenaed to court and NOT allowed to testify in my defense in the corrupt municipal court of Judge John Mulhern, J.M.C. and Laddey, Clark and Ryan's LLC for as known to the U.S. Attorney Eric Holder Jr., Federal District Judges in E.D. PA, the Executive Office of U.S. Attorneys, the Department of Justice's Civil Rights Division criminal Division and U.S. Attorney's Office on Dearborn St., Chicago, IL and Philadelphia, PA I have no Constitutional rights, Open Public meeting rights, Open Public Record Act rights to obtain a copy of any government record in the borough of Stanhope as my wife was also threatened by mail to our new home in Nevada as I was by the corrupt Borough Attorney of Stanhope Richard A. Stein, Esq. who has been protected for years with his corrupt law firm as have other law firms, professional engineering and professional planner firms as well as developers such as Paramount Self Storage on Rt 206, Stanhope, N.J. and ENF Development on Block 10902 Lots 10 and 12 and other development on property the firm did NOT even own.
