1. The Township of Wantage through its retained law firm has submitted a DEMAND that is outrageous as it would require the hiring of a staff about as large as that the is searching Mrs. Clinton's mails. In fact, the challenge to produce the DEMANDED records is far greater for the following reasons and in the State of NV government emails need NOT be saved:

a. The Department of Justice's Office of Information Policy in response to my repeated complaints that the U.S. Attorney, FBI and other DOJ units are violating the FOIA informed me I have to proceed to a U.S. District Court to force a response. I also telephoned, the Office of Government Information Services, noting, the statement itself was deceptive as while the OGIS can not force the U.S. Attorney to comply with FOIA its mission is to mediate. As such, I expect mediation NOT to resolve the issue and to respond to the DEMANDS of the plaintiff will in my opinion require a U.S. District Court to order such release needed for my Counter claim not only against the Town of Wantage but other parties noted in thomascaggiano.com and its adopted referenced exhibits including those defined in my prior two part Answers to the questions submitted..

b. While I am preparing a detailed letter brief with adopted referenced exhibits exceeding hundreds of pages of court records alone and thousands of other pages of records, I am unable to define the address, name, et. al. of witnesses as the Office of Gov in response to OPRA requests does NOT mailed responses as required, does NOT give the name of the redo custodian and many federal agencies only give the Office without any name, telephone number or address identified.

c. The **DEMAND** includes rationale for the claim of diversity. The statutes include those below as well as a federal question and such actions are expected to be transferred to a U.S. District Court per court of "original jurisdiction" per a defendant's U.S. Constitutional right.

d. The **DEMAND** requests how long have i been a State of Nevada Citizen and the answer is 6 years for in the State of NJ have less civil rights then in any country in the World based upon court orders issued by the corrupt Judge Hansbury, P.J.Ch on docket SSX-C-1-13 and SSX-C-43-13 consolidated as the State of Nevada Attorney General issued her letter noted on <http://thomascaggiano.com/NVattorneygeneral.pdf> has apparent federal crimes that rise to life or death sentences 18 U.S.C. § 241 and § 242 among others and my letter to the corrupt Supreme court of NJ Clerk and its corrupt ACJC and OAC published on <http://thomascaggiano.com/acjcglenngant.pdf>
